**Motor Vehicle Idling (Fixed Penalty) (Amendment)
Regulation 2024**

(Made by the Secretary for Environment and Ecology under section 31 of the Motor Vehicle Idling (Fixed Penalty) Ordinance (Cap. 611))

1. Commencement

This Regulation comes into operation on 30 September 2024.

2. Motor Vehicle Idling (Fixed Penalty) Regulation amended

The Motor Vehicle Idling (Fixed Penalty) Regulation (Cap. 611 sub. leg. A) is amended as set out in sections 3 and 4.

3. Section 5 amended (payment of fixed penalty)

(1) Section 5(1)(e)—

Repeal

“or”.

(2) Section 5(1)(f)—

Repeal the full stop

Substitute

“; or”.

(3) After section 5(1)(f)—

Add

“(g) through the Faster Payment System established by the Hong Kong Monetary Authority, commonly known as FPS.”.

Explanatory Note

This Regulation amends the Motor Vehicle Idling (Fixed Penalty) Regulation (Cap. 611 sub. leg. A) (*principal Regulation*) to—

- (a) specify that a fixed penalty payable under the Motor Vehicle Idling (Fixed Penalty) Ordinance (Cap. 611) may be paid through the Faster Payment System established by the Hong Kong Monetary Authority, commonly known as FPS; and
- (b) correspondingly update Forms 1 and 2 in the Schedule to the principal Regulation.
