# **Declaration of Change of Titles (Office of the Government Chief Information Officer, Government Chief Information Officer, Deputy Government Chief Information Officer, Commissioner for Efficiency and Deputy Commissioner for Efficiency) Notice 2024**

(Made by the Chief Secretary for Administration under section 55 of the Interpretation and General Clauses Ordinance (Cap. 1))

### **1. Commencement**

This Notice comes into operation on 25 July 2024.

### **2. Change of titles of public body and public officers**

Each title specified in column 2 of Schedule 1 is declared to be changed to the title specified opposite to it in column 3.

### **3. Enactments amended to reflect change of titles**

The enactments specified in Schedule 2 are amended as set out in that Schedule.

### **4. Substitution of titles in instruments, contracts or legal proceedings**

For each title specified in column 2 of Schedule 3, the title specified opposite to it in column 3 is substituted wherever it occurs in an instrument or a contract made before 25 July 2024 or in any legal proceedings commenced before that date.

## Explanatory Note

This Notice declares a change in the titles of—

- (a) the Office of the Government Chief Information Officer;
- (b) the Government Chief Information Officer;
- (c) the Deputy Government Chief Information Officer;
- (d) the Commissioner for Efficiency; and
- (e) the Deputy Commissioner for Efficiency.

2. The Notice also consequentially amends—

- (a) the references to the Government Chief Information Officer and to the Office of the Government Chief Information Officer in—
  - (i) the Dangerous Drugs Ordinance (Cap. 134);
  - (ii) the Electronic Transactions Ordinance (Cap. 553);
  - (iii) the Court Proceedings (Electronic Technology) (Magistrates' Court) Rules (Cap. 638 sub. leg. B);
  - (iv) the Court Proceedings (Electronic Technology) (District Court Civil Proceedings) Rules (Cap. 638 sub. leg. C); and
  - (v) the Court Proceedings (Electronic Technology) (District Court Criminal Proceedings) Rules (Cap. 638 sub. leg. D); and
- (b) references to the titles of the following public body and public officers wherever occurring in any instruments, contracts or legal proceedings made or commenced before 25 July 2024—

- (i) the Office of the Government Chief Information Officer;
- (ii) the Government Chief Information Officer;
- (iii) the Deputy Government Chief Information Officer;
- (iv) the Commissioner for Efficiency; and
- (v) the Deputy Commissioner for Efficiency.
