### Explanatory Note

The Maritime Safety Committee of the International Maritime Organization passed resolution MSC.496(105) on 28 April 2022. The resolution adopts amendments to Chapter IV (amongst others) of the Annex to the International Convention for the Safety of Life at Sea, 1974 (*Chapter IV*). This Regulation amends the definition of *Radio Regulations* in regulation 3 of the Shipping and Port Control Regulations (Cap. 313 sub. leg. A) (*principal Regulations*) to reflect the relevant amendment to Chapter IV.

2. This Regulation also amends the principal Regulations—
  - (a) to replace existing geographical co-ordinates based on the Hong Kong 1980 Geodetic Datum (HK80) by geographical co-ordinates based on the World Geodetic System 1984 (WGS 84); and
  - (b) to update the list of very high frequency (*VHF*) channels, VHF sectors, cable reserves, anchorages and calling-in points.
